Declaration: I,, the Adopter, hereby apply for the adoption of the above mentioned HAWS animal and agree to comply with the following conditions:

- I agree to a pre-adoption home check of the premises where the animal will be kept.
- I agree to allow HAWS access to the animal for inspection at any time after the adoption has taken place.
- I undertake not to rehome the animal to any 3rd party.
- If I am unable to keep the animal for any reason, I agree to return the animal to HAWS.
- I agree that the animal will never be caged, unless for transportation purposes and that the animal shall never be chained and/or tied up.
- If the animal is not sterilized within 6 months, I agree that HAWS is entitled to remove the animal and revoke my ownership of the animal.
- I agree to provide the animal with fresh water, food, good shelter, love, and attention.
- I agree to keep the animal in a healthy and parasite free condition. I also agree that I shall obtain immediate veterinary care should the animal become sick or injured, and I shall take full financial responsibility for any and all veterinary expenses.
- I agree to have the animal checked annually by a veterinarian and agree to provide the necessary vaccinations as advised by the veterinarian.
- I confirm that my other animal/s's vaccinations/innoculations are up to date.
- I promise NOT to declaw the animal if a cat as I understand that declawing is the painful amputation of the first knuckle, which renders the cat defenseless and inflicts unnecessary pain that may lead to lifelong behaviour and/or litter box issues.
- I hereby indemnify HAWS and its directors, founders, representatives, volunteers, and assigns from any and all financial and/or legal liability arising from the adoption and/or behavior and/or actions of the animal covered in this adoption contract. I understand that this agreement discharges HAWS and its directors, founders, representatives, volunteers, and assigns from any liability to myself and my spouse, heirs, executors, other animals and assigns, with respect to bodily injury, personal injury, illness, disease, amputation, scarring, death, property damage or other loss that may result from the adoption and/or behavior and/or activities of the adopted animal.
- On the signing of this agreement I undertake to pay the adoption fee of R This amount is to defray HAWS' expenses incurred for food, shelter, veterinary care, sterilization and the animal's 1st vaccination. HAWS will cover no further expenses nor refund the adoption fee once the adoption is finalized. Additional donations are welcome.
- I understand that HAWS has the legal right to confiscate the animal without warning, should I or any of my representatives not comply with any of the above mentioned conditions.
